MOTION FOR ARREST WARRANT. Facts proving probable cause to issue  
an arrest warrant are contained in the police report of Officer  
Brian Dale of the Gladstone Police Department that report  
reflects that on December 31, 1995, he stopped a vehicle for  
failing to obey a traffic control device at 99E and Glen Echo,
